## **QUARANTINE, ISOLATION, & RETURN TO SCHOOL**

Your safety, and that of the school community, is a priority.

**REQUIRED 14-DAY QUARANTINE (EXPOSURE)** 

If a student or staff member is exposed to a person who tested positive COVID-19, they must self-quarantine and monitor symptoms for fourteen (14) days from the last date of exposure.

Notify your school nurse. Staff should also notify their Principal or direct supervisor and Human Resources.

- Exposure (close contact) is defined as someone who has spent 15 minutes of continuous exposure at less than 6 feet apart (with or without wearing a mask) **OR** 15 minutes of **cumulative** exposure at less than 6 feet apart over a 24-hour period (with or without wearing a mask). This exposure must occur during the infectious period which begins 2 days prior to symptom onset, or specimen collection for asymptomatic cases, and extends 10 days for the majority of people.
- The 14-day quarantine period is necessary because it can take up to 14 days for the symptoms to appear in exposed individuals. For that reason, even if you test negative for COVID-19 or feel healthy, you must remain quarantined for 14 days before returning to school/work.
- Individuals can spread the disease to others for several days before they know they are sick.
- The school nurse must be notified if a student or staff member becomes sick during the quarantine period. *Individuals* who become sick during quarantine must begin a 10-day isolation period.
- The exposed student or staff member must maintain careful self- quarantine at home from other family members. Family members are only considered "contacts of a contact". They have never been exposed to a positive person. Family members of an exposed person do not need to quarantine. If the exposed person tests positive, the family members would then be considered exposed and must quarantine for 14 days.
  - **REQUIRED 10-DAY ISOLATION (COVID POSITIVE AND/OR COVID SYMPTOMS)**

If a student or staff member is diagnosed with COVID-19 or has been sick with COVID-19 symptoms, the individual must isolate **for at least 10 days** and cannot return to school until:

- A minimum of 10 days has passed since the start of the symptoms, and
- The student/staff member has been fever-free (less than 100.0 F) for at least 24 hours without taking fever reducing medication **and** symptoms have improved.
- **EXCLUSIONS TO 10-DAY ISOLATION/RETURN TO SCHOOL**

A student or staff member may return to school before the end of the 10-day isolation period, if they can:

- Present a negative COVID-19 PCR test result (Rapid Antigen Tests will not be accepted, unless accompanied by medical clearance.)
- Verify that the student or staff member has been fever free (less than 100.0 F) for at least 24 hours (without the use of fever-reducing medication).

## **ADDITIONAL REQUIREMENTS**

- Prior to a student returning to school after a period of illness or exposure, the parent/guardian must contact the school nurse and provide proper documentation. In addition, those who tested positive with COVID-19 will receive guidelines from the school nurse on how to complete the return to school survey.
- Anyone who suspects they are ill and has not received a COVID-19 test, or who is waiting to consult their medical
  provider, must NOT attend or visit school or participate in school activities while awaiting test results or final
  diagnosis.
