WHEREAS, upon the Board and Local 469 negotiated in good faith and came to an agreement during negotiations regarding revisions to the provisions of the July 1, 2016 to June 30, 2020 agreement, the terms of which are memorialized in the drafted Memorandum of Agreement; and

WHEREAS, upon the Board's approval of this resolution, this Memorandum of Agreement will be incorporated into the provisions of the new collective bargaining agreement in effect from July 1, 2020 to June 30, 2025.
